 - September 2025 financials-Jason Coleman -net surplus \$1.3 million on total revenues of \$17.17 million
 - FY2025 financials- Development beat \$2.9 million goal raising more than \$3.86 million, Round-Up and unbudgeted bequest donations resulted in \$4.26 million raised
 - FY2025 ended with a net surplus of \$1.3 million on total revenues of \$17.17 million. Part of the surplus is due to generous donors after the 2 tornados and 1 flood that we experienced which totaled \$632,000.
