

BOARD RESOLUTION APPROVAL OF THE FY2023 STRATEGIC "A" PRIORITIES

At the Thursday July 28, 2022, meeting of the Board of Directors of Society of St. Vincent de Paul Archdiocesan Council of St. Louis, the following recommendation was proposed and approved.

WHEREAS, the Board conditionally approved the five Focus Area (FA) priorities and associated Strategic Objectives of the 2022-2025 Strategic Plan at the January 27, 2022, Board meeting, and

WHEREAS, the Board Champions, Accountable Leaders and Council Staff have refined the subsequent Strategic Objectives within each FA and drafted specific goals (referred to as SMART Goals) for these objectives, and

WHEREAS, the Council staff established timelines, priorities, and estimated costs associated with each goal, and

WHEREAS, the Finance Committee recommends approval of the "A" strategic goals for FY2023 funded from Board Designated Funds (see attached enclosure entitled "A" Priorities Sorted by Estimated Cost"),

BE IT RESOLVED the Board approves the funding of the "A" strategic goals for FY2023 from Board Designated Funds at a cost not to exceed \$533,500.

BE IT FURTHER RESOLVED, the funding of remaining FY24-25 goals will be addressed during the annual budget process.
