LEGAL SERVICES RESOLUTION OF THE BOARD OF DIRECTORS OF SOCIETY OF ST. VINCENT DE PAUL ARCHDIOCESAN COUNCIL OF ST. LOUIS

WHEREAS, the Board of Directors of the Society of St. Vincent de Paul Archdiocesan Council of St. Louis ("Corporation") has determined that there is a need in the region served by the Corporation for legal services to the needy; and

WHEREAS, the Board of Directors of the Corporation has determined that it would be beneficial to the religious and charitable purposes of the Corporation to authorize the formation of a new Missouri nonprofit corporation which would have the purpose of providing, without compensation, legal services to the needy in accordance with the Vincentian principles of spirituality, service and friendship with those in need.

THEREFORE, BE IT RESOLVED, that the Board of Directors approves and authorizes:

- 1. The formation of a Missouri nonprofit corporation to be named St. Vincent de Paul Legal Services Archdiocesan Council of St. Louis ("Legal Services Corporation").
- 2. The Articles of Incorporation and Bylaws for the Legal Services Corporation in the form attached hereto are hereby approved.

- 3. As the Member of the to-be-formed Legal Services Corporation the Corporation, through its Board of Directors, hereby designates and approves the following persons to serve as the first Board of Directors of the Legal Services Corporation:
 - o Michael Forster, Founding Member, Legal Services
 - o John Foppe, Executive Director, St. Louis Archdiocesan Council, SVDP
 - o John Heithaus, Director, Vincentian Services
 - O Steve Rupp, Manager, Vincentian Conference Relationships
 - o Jeff Bunten, Esq; District President, Southwest District
- 4. The Corporation is authorized to transfer \$5,000 to the Legal Services Corporation to provide for its startup costs.
- 5. The officers of the Corporation and the Executive Director of the Corporation, or any of them, are authorized to execute any documents required to complete the actions authorized by this resolution.
