You may have noticed our logo change at the top of this newsletter. This year we are celebrating our 175th Anniversary of our founding in St. Louis!



Free Tax Help for Neighbors

Neighbors in Need with a household income less than \$56,000 in 2019 qualify to receive help. Share locations and information found at the links with your Neighbors and help them **get free tax help.**



The St. Louis Tax Assistance Program (TAP), in partnership with the IRS, offers free tax preparation services to low and moderateincome families. TAP helps families obtain the tax credits they are eligible for and avoid costly income tax preparation fees.

Facts on Medicaid and Medicaid Expansion



Medicaid in Missouri Today

- MO HealthNet is Medicaid.
- 66% of Medicaid funding comes from the Federal Government, 34% is funded by the State.
- In Missouri, public funds may not be used for abortions except to save the life of the mother.

Medicaid Expansion

- According to the Kaiser Family Foundation, approximately 219,000 more individuals will be eligible for coverage.
- 90% of Medicaid funding will come from the Federal Government, 10% will be funded by the State.
- 36 states and the District of Columbia have expanded Medicaid eligibility.

Thank you to everyone who has helped this family and helped further the mission of the Society of St. Vincent de Paul in the works.


