Program Updates

New Prescription Program Voucher

Please begin using the new Prescription Program voucher ASAP (click the link below). Optum RX purchased Castia and now fulfills medications for our Neighbors through our Prescription Program. As a result, we've updated our Prescription Program vouchers. You may print as many as you need.

Important information:

- 1. Doctors should fax the completed form to 800-491-7997.
- 2. Neighbors with questions should call 866-516-1121.
- **3.** Neighbors who are new to the program can take up to 24 hours to be activated in the Optum system. Once activated, their prescriptions will be fulfilled as long as the prescriptions are included in the formulary. (The formulary remains the same.)

House Fires

Recently, the Society has helped many Neighbors who have experienced a house fire. This is a reminder to our Conferences regarding house fires: the Disaster Committee requests that you complete the **Disaster Relief Form** for the Neighbor, which can be found on our web site. Generally, the Disaster Program will fund the expense of thrift vouchers and utility payments. Vouchers valued at over \$500 must be approved by a member of the Disaster Committee prior to giving the voucher to the Neighbor. Store vouchers need to be itemized to list the specific items that the neighbor needs.

Missouri Emergency Rental Arrears Program (ERAP)

The Missouri Housing Development Commission launched a program to provide relief to property owners and tenants impacted by the pandemic. ERAP offers a one-time payment of up to 6 months of past due rent directly to landlords on behalf of qualified tenants. Landlords must agree not to file eviction for nonpayment for 120 days and tenant households must be below 50% of the area median income.

Rapid Rehousing Pilot Program

The Society of St. Vincent de Paul is excited to launch a new Rapid Rehousing Pilot Program in collaboration with St. Patrick Center. The pilot is for St. Louis City and County residents with the goal of expanding to more counties at a later date. The program begins Monday, January 11 and will provide assistance to Neighbors who are at risk of homelessness or who have been homeless for 30 days or less.
