



### **Program Updates and Resources**

#### **Rent Crisis Update**

With an end to State Assistance for Housing Relief (SAFHR), SVdP Conferences are reporting an increase in calls from Neighbors needing rental assistance. We've heard the following from you:

- Neighbors owe a significant amount in past due rent.
- Neighbors became dependent on SAFHR and are not prepared to pay their rent.
- Monthly rents have increased significantly.
- Neighbors are facing eviction or have been evicted.
- Neighbors cannot find a landlord that will rent to them.



The Program Team at the Council Office offers the following guidance:

- 1. Paying a Neighbor's rent can prevent homelessness for the Neighbor.
- 2. Empower our Neighbors to be part of their solution. What are they doing to improve their situation? What can they contribute to the rent that is due?
- 3. Many Neighbors will receive a significant tax return. How can they use this to better their situation?
- 4. Prioritize the need and help where you can. Consider if the Neighbor will be able to maintain the rent going forward.

The National Low Income Housing Coalition indicates that Missouri has a shortage of over 114,000 affordable, available rental homes for extremely low-income renters. If our Neighbor earns Missouri's minimum wage \$11.15 per hour, a Neighbor must work 61 hours per week to afford a two-bedroom rental.

If your Conference needs financial assistance to provide help to a Neighbor, ask for twinning. Many Conference have resources to help.

If you are a Conference with a surplus of funds, contact the Council Office and we can connect you with a Conference in need.

We are excited to announce our 2023 Vincentian Wisdom Series! These Zoom sessions will feature wisdom from Vincentians and staff members on important and timely topics.





## Vincentian Funds Outside the Vincentian Family



Q: Can our Conference help donate money or goods to another ministry with their service to the poor?

A: Regarding the use of funds, Statute 26 of the Rule states: The funds of the Society shall be used for the works of the Society, including Vincentian twinning and collaboration in payments for people we serve. However, no matter how worthy the cause funds shall not be diverted in the form of donations or contributions to other organizations or charities, except occasionally for other

branches of the Vincentian Family. The Treasurer is charged as the responsible officer to ensure adherence after consultation with the Conference or Council.

Donations and gifts by donors for a certain purpose can only be applied for that same purpose and all reasonable steps will be taken to respect the wishes of donors.\*

\* If Vincentians are not involved or only marginally involved in helping Neighbors the other ministry, then it is considered a donation to another organization and therefore against the Rule. If several Vincentians are actively involved on a regular basis in helping those in need in this ministry, it can be considered a Vincentian work and therefore the contribution is valid.

#### Why did I decide to become District President







## Vincentian service to others in need embodies a mission to serve Christ, see His face in others



There's always something happening at St. Vincent de Paul Parish. One of the oldest churches in the city of St. Louis, it has been a mainstay in the community for 180 years and long known for its outreach to the poor.

A recent rainy Friday morning was no different. A group of men unloaded a van filled with fresh foods donated from a nearby Fields Foods grocery store.

Those items were placed on tables in the parish hall for anyone in the community to stop by and take what they wished. Meanwhile, two women volunteers distributed lunches to go at a window. Vincentian Father Dan Thiess was buzzing around the parish hall, helping where he could until he had to leave to celebrate the noon Mass.

"Our mission is to follow Christ, the evangelizer of the poor," he said. St. Vincent de Paul, the founder of the Vincentians, "didn't say 'come follow me,' he said 'follow Christ.' And Christ set the example for us."

#### From the Voice of the Poor

#### **ACTION ALERTS**

Your Help Needed on the following Priorities

Urge the MO House to Support Benefits Cliff Legislation

Neighbors who participate in public assistance programs such as food stamps (SNAP), temporary assistance for needy families (TANF), and childcare subsidies risk losing those benefits if they receive a promotion or a pay increase. In some cases, the increased income from the promotion or pay raise puts them over the income threshold for receiving benefits, resulting in them falling off the "benefits cliff." This creates a disincentive for recipients to better themselves, since the loss of benefits can be greater than the pay increase, making the recipient worse off. On February 23, the Missouri Senate passed SB 82 by a vote of 30-3. SB 82 would allow Neighbors receiving public assistance to take a pay increase without losing their benefits all at once. Instead, Neighbors would receive reduced benefits commensurate with their increased earnings. A similar Missouri House bill, HB 719, is awaiting a vote by the full House.

What You Can Do: <u>Click here</u> to urge your State Representative to vote Yes on HB 719.

#### Protect SNAP in the Reauthorized Farm Bill

The current federal Farm Bill expires in September and will be reauthorized for another five- or six-year term. The bill sets U.S. policy on Supplemental Nutrition Assistance Program (SNAP) and emergency food assistance programs, international food aid, conservation programs, agriculture subsidies, rural development programs, and more. It's imperative that the reauthorized Farm Bill provide access to nutritious food for the poor and hungry, offer effective support for the family farmers who produce our food, and promote good stewardship of the land. As Vincentians, we know the criticality of nutrition programs like SNAP, and our voices can help protect these programs from harmful cuts.

What You Can Do: Hold a letter-writing campaign to Senators Hawley and Schmitt and your U.S. Representative. <u>Use this SVDP letter to Congress as a guide.</u>

#### Prepare Neighbors for Medicaid Eligibility Verification

The Missouri Family Support Division is beginning to verify the eligibility of all Missouri residents currently enrolled in MO HealthNet (Missouri Medicaid). The verification process has been paused for three years due to the pandemic. If additional information is needed to verify eligibility, enrollees will receive request forms in the mail about a month before their renewal date. During the last verification process in 2019, many eligible participants lost coverage when renewal letters were sent to incorrect or outdated addresses.

What You Can Do: Remind Neighbors on Medicaid to report any address change in the last three years online or by calling 1-855-373-4636.
